The Cloud Computing Association in Taiwan this year will again participate to the "13th Cross-strait Information Industry and Technical Standards Forum" organized jointly by the Sinocon Industrial Standard Foundation, the China Electronics Standardization Association (CESA) and the China Communications Standards Association (CCSA), and during the "Cloud Computing Branch Forum", with the chairman of the Cloud Association's Committee on Cross-Strait Affairs George Wang and the chairman of the Committee on Cloud Technology Experts Shiaw-Shian Yu serving as co-convener on the Taiwan side, leading Taiwan side's exchanges with Mainland China's expert group, and the two sides will jointly published the achievements in this year's annual cooperation in promoting the common standards.

The "13th Cross-strait Information Industry and Technical Standards Forum" organized jointly by the Sinocon Industrial Standard Foundation, the China Electronics Standardization Association (CESA) and the China Communications Standards Association (CCSA), will be held from Sep. 6-7 at the Sun Island Garden Hotel in Harbin City, Heilongjiang Province, attendees will include Mainland China's Ministry of Industry and Information Technology (MIIT) Vice Minister Huai Jinpeng and the senior leadership of the Taiwan Affairs Office, will lead the top management from the relevant departments and the top management from Mainland China's communication corporate to attend the meeting.

During this year's opening ceremony, executives from CCAT will participate in the common standard announcement ceremony, and in the MOU signing ceremony with the head of the Software & Information Service Department.



Cloud Computing Branch Forum

The Cloud Computing Branch Forum is scheduled to be held on Sep. 7 (Tue.) from 2:00 ~ 5:00 PM, based on the exchange results of both sides' committee the past year; they have reached the following consensus:

- Compile Applications version 2.0, add applied cloud computing, Internet of Things,
 Big Data, open source and other technologies; on the basis of existing cases, seek
 opportunities for cross-strait industry cooperation opportunities and projects, promote
 the implementation of cross-strait industrial cooperation.
- Promote common standard of production and dissemination for "Key-based cloud data management application interface", "Overall technical requirements for whole cabinet servers" and "Technology requirements for micro-modular data center", and carry out joint testing and validation.
- 3. Start the development work for "Technical requirements for whole cabinet server sub-system", "Technical requirements for whole cabinet server management sub-system" and "Testing and certification specifications for whole cabinet servers ".
- Co-organize cross-strait open source competition, timely release results of open source competitions, and share the innovation of cross-strait open source technology and applications.

According to the above consensus, this year expert from both sides will be divided into four groups to actively promote the relevant works, and during this forum they will publish the results of the joint efforts, and continue to seek consensus to promote cross-strait cooperation and collaborative project-related work.

With the continued efforts from technical experts on both sides over the years, cross-strait exchanges and cooperation projects have been unfolding into valuable results, and it is also expected that Member companies and experts from CCAT will join the festivities, and actively participate in the cross-strait exchanges and cooperation activities co-organized by and with the participation of the CCAT.
